(a) Department Update - June 2017

#### **Calls for Service**

During the month of May, 2017 Wingham Police responded to 178 calls for service 15 of those calls were assisting the OPP and five of those calls were actual dispatches to OPP area. During the same period in 2016, we had 161 calls. Attached is the crime statistics summary.

#### OACP

I attended OACP Annual General Meeting in Waterloo from 11 – 14 June. This conference consisted of several very good educational sessions. One point mentioned was that the funding for the CPP and 1000 officers grants will be continued to the 2018/2019 year.

#### **OAPSB** Conference

Along with members from the board, I will be attending the OAPSB Annual General Meeting and training Conference from 21-24 June.

#### Grants

Our grant approvals for the 2017/2018 1000 Officers/CPP and RIDE grants have been submitted to the ministry.

#### **OPP Costing**

The OPP have again requested additional information from the service with regard to the number of trained individuals in certain areas of policing as well as our equipment used. Some of that information had been provided during the initial communication with Sgt Hummel however since he has retired it appears that not everything was passed to the new Sergeant in charge of our costing, Peter Marshall. That information has been provided. There is still no word on when the presentation to Council will take place.

#### **Crime Plotter**

One of my goals was to get us involved in Crime Plot. This is an initiative set up by Midland Police to map crimes in the area. Several other services have joined with Midland and we recently went online with them. Through this website anyone can access a map which plots our calls for service. #### **BOARD REPORT SEPTEMBER 2017**

#### CALLS FOR SERVICE

During the months of June to August, 2017 Wingham Police responded to 412 calls for service 24 of those calls were assisting the OPP and 17 of those calls were actual dispatches to OPP area. During the same period in 2016, we had 391 calls. Attached is the crime statistics summary and the Uniform Crime Reporting information that was sent to Statistics Canada.

#### **GRANTS**

Our grant approvals for the 2017/2018 1000 Officers/CPP and RIDE grants have been received.

#### **OPP COSTING**

The OPP Costing will be presented to Council on 25 September in the theatre at the town hall. From what I have been told, this meeting will be open to the public however any questions for the OPP will be restricted to councillors.

#### **OIPRD**

There are currently two complaints being investigated by the OIPRD.

The director is conducting a review of arrests and strip searches. He has requested information for the past three years regarding this. On average we have conducted 51 arrests a year and there have been no requirements for strip searches. This information has been relayed to the director.

#### **TRAINING**

Use of force refresher training will be conducted during the month of October with Saugeen Shores Police Service.

#### REFUGEE FAMILY

The Wingham community has sponsored a family from Syria. This family has had a meeting with an officer from our service and an Arabic speaking officer from Huron OPP. They have been provided all contact information should they have any problems and we have connected with their translator.

#### SCHOOL OFFICERS

With the start of school, we will again be assigning specific officers to assist the schools for presentations etc. We have done this for the past two years and it seems to be working well. Of course any officer will respond to calls whenever called.







#### Dear Minister Lalonde and Attorney General Naqvi,

Please find attached our review of Chapter 9 of Justice Tulloch's Independent police Oversight review Report, as requested by you during our round-table discussions of 23 April 2017.

Notably, we concur with recommendations 9.12 that MCSCS (rather than OCPC) is the most appropriate agency to determine whether municipal decisions regarding the establishment the policing capacity and the funding of it, are congruent (or not) with the provincial legislation, policies and standards of which MCSCS has carriage.

Furthermore, we concur with all of Justice Tulloch's recommendations with the following exceptions:

- 9.3 Policy and service matters should be referred to the **police services board** of the relevant force, and the chief of police.
- 9.11 OIPRD should investigate conduct and performance of all police personnel, including special constables and auxiliary members, AND special constables employed in non-police agencies [because, from the public perspective, they have similar special powers and should therefore have the same oversight]. Given OIPRD's investigative role regarding police personnel conduct, by logical extension OIPRD should also be responsible to investigate board member conduct.
- 9.11 Municipalities should investigate non-criminal conduct and performance of bylaw enforcement personnel

In an effort to better address the timely appointments for provincial members to police services boards, we are currently reviewing the appointments process as we continue to work to fill current vacancies. If there are individual boards that are having quorum issues in relation to a provincial vacancy, I would encourage those boards to reach out to their appropriate ministry Police Services Advisor to bring this to our attention.

Police services boards play an essential role in building and maintaining strong partnerships between the police and our communities. I am confident that with your support, we will continue to ensure that boards across Ontario are comprised of capable and committed members, serving our communities.

In 2017/18, the Ministry of Community Safety and Correctional Services (ministry) began transforming its grant programs to better support local community safety and well-being initiatives across the province. As part of this transformation, the ministry introduced the Policing Effectiveness and Modernization (PEM) grant to support initiatives that improve the effectiveness, efficiency and modernization of policing services. The PEM grant aims to provide greater flexibility to police services and boards to focus their funding on implementing initiatives that address local needs.

The PEM grant was introduced as a transitional program for police services/boards who participated under the Provincial Anti-Violence Intervention Strategy (PAVIS), Toronto Anti-Violence Intervention Strategy (TAVIS), Community Policing Partnerships (CPP) and Safer Communities -1,000 Officers Partnership (1,000 Officers) programs as the ministry moves towards a future outcomes-based grant program that aligns with the Strategy for a Safer Ontario.

In 2017/18, police services/boards were provided the choice to apply for funding under the PEM grant based on local need <u>or</u> receive funding under the previous policing grants with traditional requirements (e.g., eligibility, reporting).

To continue to ease the transition from the traditional grant programs, in 2018/19, police services/board will again be provided the choice to apply for funding under the PEM grant <u>or</u> previous policing grants. Police services/boards may receive up to the full

amount of funding they were allocated under PAVIS, CPP, 1,000 Officers or PEM grant in 2017/18. The 2018/19 fiscal year will be the last year that the ministry will offer the PAVIS, CPP and 1,000 Officers grants. In future years, the ministry will be moving towards the full transition from the traditional policing grants to supporting outcomesbased community safety and well-being initiatives.

For First Nations police services, the PAVIS, CPP, and 1,000 Officers programs will not be changing and these police services will continue to receive the full amount of funding they were allocated in 2017/18 under these grants. This will help to ensure the policing needs of these communities are met on an ongoing basis.

Over the past few months, the ministry has consulted on the transformation of its grant programs, and has carefully considered the feedback from these consultations. We heard and understand that our stakeholders need ample time to prepare meaningful projects. As such, the deadline for the 2018/19 PEM grant application is **January 19**, **2018**. Ministry staff will work with police services/boards to ensure that they are successful in meeting PEM grant requirements and objectives.

The ministry will also offer webinars to provide information to police services/boards on their options for grant funding and further details on the PEM grant. Details on these sessions will be released at a later date.

The ministry values the input and feedback from our municipal, First Nations, policing, and community partners. I want to take this opportunity to thank all our partners who provided valuable feedback and considerations throughout this process. The ministry will continue its consultations as we move forward with grants transformation. Further information on future consultations will be communicated to stakeholders as soon as possible.
