#### **BOARD REPORT JANUARY 2018**

#### **CALLS FOR SERVICE**

During the month of December, 2017 Wingham Police responded to 106 calls for service 5 of those calls were assisting the OPP and 2 of those calls were actual dispatches to OPP area. During the same period in 2016, we had 115 calls. Attached is the crime statistics summary for the third quarter of 2017.

#### **BUILDING PROBLEMS**

Garage door has been repaired. Still no word on the roof repair.

#### **COMMUNITY PRESENTATIONS**

A citizenship/law presentation was given to both grade 12 civics classes at F.E. Madill on 9 Jan 18.

A fraud presentation was given to the St Andrews Church "Coffee Club" on 11 Jan 18.

#### **SERVICE FIREARMS**

The side arms used by the service are getting old and require replacement. Late last year the firing pin broke in one of the pistols during training. We have had this happen to two other weapons in the past. The pistol was sent to be repaired by a Sig Arms technician. The technician assessed that all of our firearms are between 25 and 30 years old and require replacement. Due to wear and tear, the metal in some of the working parts is becoming brittle and poses a safety risk to the officers. If the service remains after the OPP costing process, this will be an urgent replacement requirement.







## **NORTH HURON POLICE SERVICES BOARD**

## **BY-LAW # 01-2018**

## A BY-LAW TO GOVERN THE PROCEEDINGS OF THE TOWNSHIP OF NORTH HURON POLICE SERVICES BOARD

WHEREAS a Police Services Board may, by By-law make rules for the effective management of the police service under Section 31(6) of the Police Services Act, R.S.O. 1990 c.P.15 and amendments.

AND WHEREAS it is deemed expedient to make and establish rules governing the proceedings of the North Huron Police Services Board, the conduct of its Members and the calling of meetings, pursuant to the Police Services Act, R.S.O. 1990 c.P.15 and amendments.

THEREFORE the North Huron Police Services Board enacts as follows:

## 1. **DEFINITIONS**

- 1.1 In this By-law:
  - (a) **Act** means the Police Services Act, R.S.O. 1990 c.P.15, as amended from time to time;
  - (b) **Acting Chair** means a Member required to act from time to time in the place and stead of the Chair, pursuant to section 6 of this By-law;
  - (c) **Board** means the North Huron Police Services Board and shall be composed of such Members appointed under Part III of the Act;
  - (d) **Chair** means the Chair of the Board;
  - (e) **Chief of Police** means the Wingham Chief of Police reporting to the North Huron Police Services Board;
  - (f) **Committee** means a Standing or ad hoc committee and any other similar entity composed of individuals of the Board pursuant to the Act;
  - (g) **Council** means the Council of The Corporation of the Township of North Huron;
  - (h) **Days** means calendar days exclusive of Saturday, Sundays and Statutory holidays;
  - (i) **Secretary** means the Secretary of the North Huron Police Services Board;
  - (k) **Member** means a Member of the North Huron Police Services Board;
  - (I) **Recorded Vote** means the making of a written record of the name and vote of each Member present who votes on a question and of each Member present who does not vote;
  - (m) **Municipality** means the Township of North Huron.
- 1.2 In this By-law, words importing the singular number include the plural and vice versa, and words importing the masculine gender include the feminine gender.

## 2. APPLICATION

- 2.1 The rules or procedures contained in this By-law shall be observed in all proceedings of the Board and shall be the rules for the order and dispatch of business before the Board, and with necessary modifications, in a committee of the Board;
- 2.2 Except as provided elsewhere in this By-law, the Board may temporarily suspend one or more of the rules contained in this paragraph by a vote of the majority of the Members present:
  - (a) Rules with respect to a change in agenda order of proceedings and content;
  - (b) Rules respecting notice of delegation status;
  - (c) Rules with respect to the increase or decrease of delegation and debate limitations;
- 2.3 All points of order or procedure for which rules have not been provided in this By-law shall be decided by the Chair.

#### 3. COMPOSITION OF THE BOARD

- 3.1 In accordance with Section 27(6) of the Act, the Board shall consist of five (5) Members, composed of:
  - (a) Two (2) Council Members appointed by by-law of the Council;
  - (b) One (1) person appointed by by-law of the Council, who is neither a Member of the Council nor an employee of the municipality; and
  - (c) Two (2) people appointed by the Lieutenant Governor in Council.

## 4. SELECTION OF CHAIR AND VICE CHAIR

- 4.1 In accordance with Section 28 (1) and (2) of the Act, the Members of the Board shall, at the first meeting held in January of each year, select from amongst its Members, a Chair and Vice Chair for one year.
- 4.2 The election of Chair shall be conducted by the Secretary.
- 4.3 The election of the Vice Chair shall be conducted by the Secretary.
- 4.4 Any votes required under this section, shall be taken as described by the provision of Section 244 of the Municipal Act, R.S.O. 2001, as amended, which requires that each Member present indicate his/her vote openly and that no vote be taken by ballot or any other method of secret voting.

## 5. DUTIES AND RESPONSIBILITIES OF THE BOARD

5.1 The Board shall be responsible for those duties as set out in Section 31(1) of the Act as applicable, and shall at all times discharge those duties in accordance with the Board's Code of Conduct.

## 6. DUTIES OF THE CHAIR

- 6.1 It shall be the duty of the Chair to:
  - (a) Report on the activities of the North Huron Police Service, and those of its Board, to North Huron Council quarterly and as requested;
  - (b) Act as the sole spokesperson for the major policy decisions of the Board;
  - (c) Represent and support the Board, declaring its will and implicitly obeying its decision in all things;
  - (d) Set the agenda for all meetings;
  - (e) Open the meeting of the Board by taking the chair and calling the Members to order;
  - (f) Receive and submit, in the proper manner, all motions presented by the Members;
  - (g) Put to vote all questions, which are duly moved and to announce the result thereof;
  - (h) Decline to put to a vote, motions which infringe upon the rules of procedure or which are beyond the jurisdiction of the Board;
  - (i) Restrain the Members, when engaged in debate, within the rules of procedure;
  - (j) Enforce on all occasions the observance of order and decorum among the Members;
  - (k) Call by name, any Member persisting in breach of the rules and procedure and to order him or her to vacate the room in which the meeting is being held;
  - (I) Inform the Board on any point of order as deemed necessary;
  - (m) Adjourn the meeting upon motion duly moved when the business is concluded;
  - (n) Adjourn the sitting without a question being put or suspend or recess the sitting for a time to be specified by him or her, if considered necessary;
  - (o) Sign all documents for and on behalf of the Board including but not limited to by-laws, minutes, resolutions, orders and agreements which have been approved by the Board;
  - (p) Perform any and all other duties when directed to do so by motion of the Board.

## 7. DUTIES OF THE VICE CHAIR

When the Chair is absent or refuses to act or the Chair is vacant, the Vice Chair shall act in his or her place and stead and while so acting, shall have the same authority, rights and powers of the Chair.

## 8. COMMITTEES OF THE BOARD

- 8.1 The Board may at any time, by motion, appoint one or more Members to a Committee of the Board to inquire into any matter within the jurisdiction of the Board.
- 8.2 The Bargaining Committee will consist of the Board Chair and Vice-Chair and the Secretary.
- 8.3 The Committee shall report upon its work to the Board at the meeting of the Board next following the date of the Committee meeting.

## 9. REGULAR MEETINGS OF THE BOARD

- 9.1 The Board shall hold its regular monthly meetings at 7:00 p.m. on the third Tuesday of the month in the Township of North Huron Council Chambers or at such other place or time as may be determined by the Board from time to time.
- 9.2 The Board shall not hold regular monthly meetings during the months of July and August of each year.
- 9.3 The Chair shall preside at all meetings. In the absence of the Chair, the Vice Chair or in the absence of the Vice Chair, the next senior Member of the Board, shall preside at the meeting in accordance with Section 7 of this By-law.
- 9.4 The Chair or in the absence of the Chair, the Vice Chair as the case may be, may cancel a regular meeting of the Board, where the Chair or Vice Chair deems such meeting is not warranted.

## 10. SPECIAL MEETINGS OF THE BOARD

- 10.1 The Chair, or in his or her absence the Vice Chair, may at any time summon a special meeting of the Board and shall do so whenever requested by a majority of the Members of the Board.
- 10.2 The Secretary shall give notice to the Members of the Board of all special meetings of the Board whenever required by competent authority to do so. Such notice shall be by telephone, or other means deemed appropriate by the Secretary.
- 10.3 No special meeting of the Board may be held with less than 24 hours notice to the Members.
- 10.4 Notification of the public will be deemed complete with posted notice at the Township of North Huron Municipal Office 24 hours in advance of a meeting called under Section 10.1.
- 10.5 Notwithstanding 10.4, a meeting deemed to be In Camera, will not require notification of the public.
- 10.6 No business may be transacted at a special meeting of the Board other than that specified in the notice or Agenda.

#### 11. THE CALLING OF THE MEETINGS TO ORDER

11.1 As soon as possible after the hour of the meeting, and where a quorum is present, the Chair shall take the chair and call the meeting to order.

11.2 If a quorum for either the regular or special Board meeting is not present within thirty (30) minutes of the time fixed for the commencement of the meeting, the Secretary shall indicate that no quorum was present and the meeting shall stand adjourned until the next regular meeting of the Board.

## 12. QUORUM

A quorum shall be a majority of the Members according to Section 35(2) of the Police Services Act.

#### 13. BOARD AGENDA

- 13.1 The Secretary shall cause an agenda to be prepared, in the following order, for the use of the Members at the regular meetings of the Board:
  - 1 Call to Order
  - 2 Accept or Amend Agenda
  - 3 Disclosure of Pecuniary Interest;
  - 4 Minutes of Previous Meetings;
  - 5 Delegations/Petitions/Invited Guests;
  - 6 Business Arising from Minutes;
  - 7 Police Chief's Report;
  - 8 Treasury Report;
  - 9 Bylaws and Policies for Consideration;
  - 10 Correspondence;
  - 11 New Business;
  - 12 Board Members Inquiries and Reports;
  - 13 Public Gallery Questions and/or Comments;
  - 14 In Camera Session;
  - 15 Next Meeting;
  - 16 Adjournment.
- 13.2 Every letter, petition and other communication addressed to the Board shall be received by the Secretary of the Board who shall:
  - (a) where, in the opinion of the Secretary, the subject matter of any communication is properly within the jurisdiction of the Board, place it upon the Agenda for the new regular meeting of the Board to be dealt with during such meeting;
  - (b) where, in the opinion of the Secretary, and confirmed by the Chair, the subject matter of any communication is properly within the jurisdiction of the Police Service, shall refer it to the Inspector for necessary action and a report presented at the next Board meeting if required.
- 13.3 The Secretary shall ensure that the agenda for regular meetings be delivered to each Member of the Board the Friday prior to the regular meeting.
- 13.4 All meetings may be audio and/or visually recorded, broadcast and/or streamed publicly by the Board.

## 14. CONFLICT OF INTEREST DISCLOSURE

14.1 The Chair and Members shall be governed by the Municipal Conflict of Interest Act, 1990, and the agenda shall include a provision for Members to declare a conflict or conflicts of interest or a pecuniary interest in a matter.

- 14.2 Where a Member, either on his or her own behalf or while acting for, by, with or through another, has any pecuniary interest, direct or indirect, in any matter and is present at a meeting of the Board at which the matter is the subject of consideration, the Member shall:
  - (a) prior to any consideration of the matter at the meeting, disclose the interest and the general nature thereof;
  - (b) not take part in the discussion of, or vote on any question in respect of the matter; and
  - (c) not attempt in any way whether before, during or after the meeting to influence the voting on any such question.
- 14.3 Where a meeting is not open to the public, in addition to complying with the requirements, the Member shall forthwith leave the meeting for the part of the meeting during which the matter is under consideration.
- 14.4 Where the interest of a Member has not been disclosed by reason of his or her absence from the particular meeting, the Member shall disclose his or her interest and otherwise comply at the first meeting of the Board attended by him or her after the particular meeting.
- 14.5 To fulfill the Board's functions pursuant to PART V COMPLAINTS, of the Act, Members should not take part in the administration of Part V matters if they have a personal interest or where they may be perceived as having a personal interest or bias. Where there is uncertainty as to whether a conflict may exist, the issue should be raised and the decision, in regards to the conflicts, shall be determined by the Member.
- 14.6 The Secretary shall record in reasonable detail, the particulars of any disclosure of conflict of interest, and the particulars shall appear in the minutes of that meeting of the Board.

## 15. HEARING OF DELEGATIONS

- 15.1 Delegations will only be heard at regular meetings and provided that the person(s) requesting a delegation has provided written notice of their request at least five (5) days before the date of the Board meeting or at the Chairs discretion. The request shall also include a list of person(s) who will be appearing before the Board and a copy of the materials that will be presented. Delegations shall be restricted to presentations of ten (10) minutes and shall address their remarks to the stated business. Notwithstanding the foregoing the time allotted for any delegation may be extended an addition five (5) minutes at the discretion of the Chair.
- 15.2 Upon receipt of the written notice requesting a delegation, the Secretary shall list the delegation on the next appropriate meeting agenda.
- 15.3 Upon the completion of a presentation to the Board by a delegation, any discourse between Members of the Board and the delegation shall be limited to Members asking questions for clarification and obtaining additional, relevant information only. Members of the Board shall not enter into debate with the delegation respecting the presentation.
- 15.4 No delegation shall:
  - (a) speak disrespectfully of any person;
  - (b) use offensive words or unparliamentary language;

- (c) speak on any subject other than the subject for which they have received approval to address the Board; or
- (d) disobey the rules of procedure or a decision of the Chair.
- 15.5 The Chair may curtail any delegation, any questions of a delegation or debate during a delegation for disorder or any other breach of this By-law and, where the Chair rules that the delegation is concluded, the person or persons appearing shall immediately withdraw.

#### 16. CONDUCT OF MEMBERS DURING MEETINGS

- 16.1 No Member shall:
- (a) use offensive words or unparliamentary language in meetings of the Board or against any Member;
- (b) speak on any subject other than the subject in debate;
- (c) criticize any decision of the Board except for the purpose of moving that the question be reconsidered;
- (d) speak in a manner that is discriminatory in nature based on an individual's race, ancestry, place of origin, citizenship, creed, gender, sexual orientation, age, color, marital status, family status or disability;
- (e) disobey the rules as set out in this By-law or a decision of the Chair, on questions of order or procedure as set out in this By-law or resolution of the Board, or upon the interpretation of the rules of the Board.
- 16.2 If a Member persists in disobedience after having been called to order by the Chair, the Chair shall forthwith put the question, no amendment, adjournment or debate being allowed: That such Member be ordered to leave his or her seat for the duration of the meeting of the Board. If a Member who has been ordered to leave his or her seat apologizes to the Chair and the other Members, he or she may, by vote of the Members, be permitted to retake his or her seat.

## 17. RULES OF DEBATE

- 17.1 Every Member, before speaking to a question or motion shall first receive recognition from the Chair and then the Member shall address the Chair.
- 17.2 When a Member wishes to speak to any question, motion or item, they shall in an orderly fashion attempt to obtain the Chair's attention to indicate that such Member wishes to speak, and the Chair shall keep a list of those Members who have so indicated a desire to speak. The Chair shall then recognize the Members who wish to speak in the order in which their intentions have come to the Chair's attention and appear on the list.
- 17.3 When two or more Members indicate their intention to speak, the Chair shall recognize the Member who, in his or her opinion, first indicated their intention to speak, and that Members may speak to the question or motion first.
- 17.4 When a Member is speaking no other Member shall pass information between any Member or the Chair, or interrupt that Member except to raise a point of order.

- 17.5 A Member may require the question or motion under discussion to be read at any time during the debate, but so as not to interrupt a Member who is speaking.
- 17.6 No Member shall speak more than twice to the same question or motion without leave of the Chair, except to explain a part of his or her speech which the Member feels may have been misunderstood, but in no instance, shall the Member be permitted to introduce any new matter.
- 17.7 Notwithstanding Section 17.6, a reply may be made by the Member who has presented a motion to the Board, following the conclusion of the speeches of the other Members.
- 17.8 No Member shall speak to the same question or motion, or in reply, for more than ten minutes, without leave of the Chair.
- 17.9 After a question is put by the Chair, no Member shall speak to the question nor shall any other motion be made until after the vote is taken and the result has been declared.
- 17.10 If a Member considers that a ruling by the Chair is not in order, an appeal may be made. When challenged, the Chair may give a brief explanation of the ruling and ask the Members is the ruling of the Chair upheld? In the event of a tie vote, the ruling is upheld. The decision of the Board under this Section is final.

#### 18. MOTIONS

- 18.1 All motions shall be duly moved and seconded before being discussed or being put to a vote. Motions to move "in camera" or for the passing of by laws shall be duly moved and seconded and passed to the Chair before being discussed and voted on.
- 18.2 The Board Secretary will read a motion before a vote is taken if required to do so by a Member.
- 18.3 After a motion has been moved, it may be withdrawn by the mover at any time before a vote is taken.
- 18.4 A motion properly before the Board for decision must receive disposition before any other motion can be received, except motions:
  - (a) to adjourn;
  - (b) to amend;
  - (c) to refer;
  - (d) to suspend the rules of procedure;
  - (e) to table the question;
  - (f) to vote on the question.
- 18.5 A motion to adjourn the meeting may be made at any time except;
  - (a) When a Member is speaking or during the taking of a vote;
  - (b) When the question has been called;
  - (c) When a Member has already indicated to the Chair that he or she desires to speak on the question;

and, when resolved in the negative, cannot be made again until the Board has conducted further proceedings.

#### 18.6 A motion to amend:

- (a) Shall be relevant to the question to be decided;
- (b) Shall not be received if it in essence constitutes a rejection of the main questions;

and only one motion to amend such amendment shall be permitted, and any further amendment shall be made to the main questions.

- 18.7 A motion to refer the question shall include:
  - (a) The name of the Committee, or other body or official to whom the question is to be referred; and
  - (b) The terms upon which the question is to be referred;

and, any debate will only be permitted with respect to the desirability of referring the question and the terms of the referral, and no discussion of the main question or an amendment thereto shall be allowed until after its disposition.

- 18.8 After any question, except one of indefinite deferment has been decided by the Board, any Member who was present and who voted in the majority may, at a subsequent meeting of the Board, move for the reconsideration thereof, provided due notice of such intention is given as required by this By-law, but no discussion of the main question by any person shall be allowed unless the motion to reconsider has first been adopted.
- 18.9 No question shall be reconsidered more than once at a meeting of the Board.

## 19. VOTING ON MOTIONS

- 19.1 A motion shall be deemed to have been carried when a majority of the Members present and voting have expressed their agreement with the questions.
- 19.2 When the Chair is satisfied that a question contains distinct proposals, he or she may divide the question or upon the request of a Member, shall divide the question, and the vote upon each proposal shall be taken separately.
- 19.3 Every Member present at a meeting of the Board when a question is put shall vote thereon unless prohibited by statute, in which case the Secretary shall record the name of the Member and the reason that he or she is prohibited from voting.
- 19.4 If a Member present does not vote when a question is put, he or she shall be deemed to have voted in the negative, except where the Member is prohibited from voting by statue.
- 19.5 When a recorded vote is permitted and required, except during In Camera session of the meeting, the Secretary shall conduct the vote in a counter-clock wise direction, starting on the Chair's right hand, asking the Members in favour to indicate with "yea", asking the Members opposed to indicate with "nay", and recording each vote as it is cast.
- 19.6 The Secretary will advise the Chair of the count of the vote, and the Chair will announce the results.
- 19.7 Where on any question on which there is a tie vote, the motion shall be deemed to have been lost,

## 20. PUBLIC AND "IN CAMERA" MEETINGS

- 20.1 All meetings of the Board shall be open to the public subject to subsection (20.2) of this section.
- 20.2 The following subject matters may be discussed in a closed meeting of the Board, unless prohibited by law:
  - (a) intimate financial and personnel matters, where a named or identifiable employee or prospective employee is involved, or where employee relations or reputations could be damaged, unless the employee or employees involved have requested that the matter be discussed in a meeting open to the public and the majority of the Board concurs;
  - (b) labour relations or employee negotiations matters arising out of the administration of collective agreements;
  - (c) a proposed or pending acquisition of land for Board purposes;
  - (d) litigation or potential litigation or matters in which public discussion could prejudice the Boards legal position or be detrimental to the Board in proceedings before any Court or Administrative Tribunals;
  - (e) consideration of promotions;
  - (f) matters that are specifically restricted by legislation regarding the protection of privacy;
  - (g) matters relating to the consideration of a request under the Freedom of Information and Protection of Privacy Act;
  - (h) matters involving public security, the revelation of which would endanger the security of the Board property, or the operations of the policing services.
- 20.3 No person other than Board Members, Secretary and Chief of Police and other persons invited by the Chair, shall attend closed meetings of the Board, and persons other than the Board Members shall vacate the meetings if requested to do so by the Chair.
- 20.4 The proceedings of a Board In Camera Session shall be audio/video recorded with all recordings kept in a secure location in the Township of North Huron Municipal Office.

## 21. AVAILABILITY OF INFORMATION

- 21.1 Information relating to matters described in Section 20.2 of this By-law, shall be marked Confidential.
- 21.2 Immediately following the distribution of the agenda information to all Members of the Board, the public agenda materials may be made available to the media and to any other Member of the public requesting such information, provided the disclosure of such information do not relate to maters described in subsection 20.2 herein. Such materials shall be made available at the Board office no earlier than the Monday preceding the day upon which the meeting is to be held.

## 22. BY-LAWS

- 22.1 Every By-law shall be introduced upon written motion by a Member, and any number of By-laws may be introduced together in one motion, but the Chair may, at the request of a Member, deal separately with any By-law.
- 22.2 Every By-law when introduced, shall be in typewritten form and shall contain no blanks except such as may be required to conform to accepted procedure or to comply with the provisions of any Act, and shall be complete with the exception of the number and the date of the By-law.
- 22.3 Every By-law which has been passed by the Board shall be numbered, dated and signed by the Chair and Secretary, and shall be filed by the Secretary in the Township Municipal Office, in secure and proper facilities provided by the Municipal Clerk.
- 22.4 The Board Secretary shall provide the Municipal Clerk with duplicate copies of all By-laws duly passed under Section 22.

## 23. REPORTING PROTOCOL

- 23.1 The Township of North Huron Police Services Board shall report to North Huron Council regularly, and provide such information not protected by the terms of the Police Services Act, sections 35 (4)(a)(b), and the Municipal Freedom of Information and Protection of Privacy Act, as requested by Council and deemed appropriate by the Board.
- 23.2 The Business Plan of the North Huron Police Services Board will be provided to the Council of the Township of North Huron before March 31<sup>st</sup>, 2019 and will renew said plan every three years thereafter, and submit to the Council's Clerk by March 31<sup>st</sup> of each year.
- 23.3 The Annual Report of the North Huron Police Services will be provided to the Council of the Township of North Huron by April 1st of the year following the year of activity.
- 23.4 Any Business Plan produced in accordance with article 23.2, will be made available for inspection by the public in the Municipal Office in Wingham, and other locations as the Board may direct from time to time, from the time it is approved by the North Huron Police Services Board until it is replaced.
- 23.5 The current Annual Report of the Police Services Board will be made available for inspection by the public in the Municipal Office in Wingham, and other locations as may be determined by the Board from time to time.
- 23.6 During the development of any Business Plan produced in accordance with article 23.2, the Board will consider any issues brought to their attention by Township of North Huron Council, the Avon Maitland District School Board, the Huron Perth Catholic District School Board, community organizations and groups, businesses and members of the general public for inclusion into the business plan.

# 24. CODE OF CONDUCT Members of Police Services Board — Code of Conduct — Ontario Regulation 421/97

- 24.1 Board Members shall attend and actively participate in all board meetings.
- 24.2 Board Members shall advise the Chair twenty-four (24) hours in advance of a Board meeting if they are unable to attend a meeting.

- 24.3 If any Board Member misses three consecutive meetings or a total of four meetings in a twelve (12) month period, the Board will make a recommendation to the Council of the Township of North Huron (in the case of a Council appointee) or to the Ministry of Community Safety and Correctional Services (in the case of a Provincial appointee) that the member be replaced unless the member can convince the Board members that there are circumstances that justify his/her retention.
- 24.4 Board Members shall not interfere with the police force's operational decisions and responsibilities or with the day-to-day operation of the police force, including the recruitment and promotion of police officers.
- 24.5 Board Members shall undergo any training that may be provided or required for them by the Solicitor General.
- 24.6 Board Members shall keep confidential any information disclosed or discussed at a meeting of the board, or part of a meeting of the board, that was closed to the public.
- 24.7 No board Member shall purport to speak on behalf of the board unless he or she is authorized by the board to do so.
- 24.8 A board Member who expresses disagreement with a decision of the board shall make it clear that he or she is expressing a personal opinion.
- 24.9 Board Members shall discharge their duties loyally, faithfully, impartially and according to the Act, any other Act and any regulation, rule or By-law, as provided in their oath or affirmation of office.
- 24.10 Board Members shall uphold the letter and spirit of the Code of Conduct as set out in this Regulation and shall discharge their duties in a manner that will inspire public confidence in the abilities and integrity of the board.
- 24.11 Board Members shall discharge their duties in a manner that respects the dignity of individuals and in accordance with the Human Rights Code and the Charter of Rights and Freedoms (Canada).
- 24.12 Board Members shall not use their office to advance their interests or the interests of any person or organization with whom or with which they are associated.
- 24.13 Board Members shall not use their office to obtain employment with the board or the police force for themselves or their family Members.
- 24.14 For the purpose of subsection (24.11), family Member means the parent, spouse or child of the person, as those terms are defined in section 1 of the Municipal Conflict of Interest Act.
- 24.15 A Board Member who applies for employment with the police force, including employment on contract or on fee for service, shall immediately resign from the board.
- 24.16 Board Members shall refrain from engaging in conduct that would discredit or compromise the integrity of the board or the police force.
- 24.17 A Board Member whose conduct or performance is being investigated or inquired into by the Commission under s. 25 of the Act shall decline to exercise his or her duties as a Member of the board for the duration of the investigation or inquiry.

## 25. BREACH OF CODE OF CONDUCT

- 25.1 If the board determines that a board Member has breached the Code of Conduct set out in this Regulation, the board shall record that determination in its minutes and may,
  - (a) require the Member to appear before the board and be reprimanded;
  - (b) request that the Ministry of the Solicitor General conduct an investigation into the Member's conduct; or,
  - (c) request that the Commission conduct an investigation into the Member's conduct under Section 25 of the Act.

## 26. GENERAL

- 26.1 The procedures for the investigation of complaints against the Wingham Police Service shall be in accordance with the Police Services Act.
- The Board shall enter into and adhere to a reporting protocol with the Township of North Huron Council at regularly scheduled council meetings, and provide such information not protected by the terms of the Police Services Act Sections 35 (4)(a)(b), and the Municipal Freedom of Information and Protection of Privacy Act, as requested by Council and deemed appropriate by the Board.

## 27. RECORDING EQUIPMENT

27.1 At the meetings of Board, the use of cameras, electric lighting equipment, flash bulbs, recording equipment, television cameras and any other device of a mechanical, electronic or similar nature used for transcribing or recording proceedings by auditory or visual means by members of the public, including accredited and other representatives of any news media whatsoever, will not be permitted. Only audio and/or video recording devices operated by Township Staff shall be allowed during the meetings of the Board.

## 28. COMMUNICATION DEVICES

- 28.1 At the meetings of the Board, the use of cellular phones, audible pagers or any other similar communication devices creating a disruption, or a nuisance will not be permitted in the Council Chambers
- 28.2 An exception would be granted to allow members of the Board and Staff the opportunity to use electronic devices to set meeting dates when necessary;

## 29. ADMINISTRATION

- 1. This By-law will come into force and effect on the final passing hereof.
- 2. This By-law will rescind By-law 01-2011.

## 30. EFFECTIVE DATE

This By-law is hereby enacted by the Township of North Huron Police Services Board on this 23<sup>rd</sup> day of January, 2018, and shall take effect on this date.

## ONTARIO ASSOCIATION OF POLICE SERVICES BOARD ZONE 5

### By-Law No. 01 - 15

#### <u>ARTICLE 4 – MEMBERSHIP</u>

Subject to Article 5, every Police Services Board that is a member in good standing of the OAPSB and is located within the territorial boundaries of the Zone may be a member of Zone 5, upon receipt of annual membership dues.

Every member Police Services Board shall have one vote with respect to election(s) of Zone Officers.

#### **ARTICLE 5 – MEMBERSHIP DUES**

Fees for membership of the Zone shall be determined by a simple majority of the Boards present at the last meeting of the term prior to the OAPSB Annual General Meeting.

Fees for membership of the Zone shall be due within 30 days following the Annual General Meeting.

#### <u>ARTICLE 6 – ZONE OFFICERS</u>

#### Chair, Vice Chair, Director and Zone Secretary/Treasurer

#### <u>Section 1 – Term of Office</u>

The term of office for Zone Officers shall be one year commencing immediately after the OAPSB Annual General Meeting or shall end on commencement of the next term. In addition, should the said officer no long be a member of their PSB, their term of office shall cease at the next Zone 5 meeting and a replacement officer shall be elected if balance of the term is more than 50% of the total term of office, or appointed by the remaining two officers if balance of term is less than 50% of the term of office."

### <u>Section 2 – Nomination and Elections</u>

(a) Nomination and Election of Chair, Vice Chair and Director.

At least 30 days prior to the date of election, the Zone secretary/Treasurer will, provide formal notice to all Police Services Boards in Zone 5, requesting nominations for Zone officers – Chair, Vice Chair and Director.

In the event that an election is to be carried out during the term of office, due to a vacancy occurring, actions in (A) will be taken. However, time may not permit a 30 day notice period, before the next meeting when the election will be held. In this event, a minimum of two (2) business days' notice will be given to the member Boards. Should the vacancy be immediate, one of the two existing officers will double up and become 'acting' during the vacancy time.

- (b) Nominations will be made from the floor during the Zone meeting the day of the election. And, the Zone Secretary/Treasurer shall announce those names of proposed candidates who have filed their interest to be nominated for the respective Zone Officer.
- (c) Elections will be held during the last meeting of the term of office.
- (d) Election shall be by paper ballot with a simple majority of the Boards present. 'Proxy voting' shall be permitted subject to receipt by the Zone Secretary/Treasurer of a resolution from the respective Police Services Board's approval.
- (e) Elections shall take place immediately prior to adjournment of the Zone meeting.
- (f) Appointment of Zone Secretary/Treasurer

At the time of Elections, the Zone Secretary/Treasurer shall be appointed by a vote of a simple majority of the Zone membership and shall be a secretary to a Board that is a member of the Zone.

(OCA 2017) decision

#### Introduction

This memo deals with the Court of Appeal's decision in *R. v. M.G.T.*, 2017 ONCA 736 and how the disclosure of 911 calls is dealt with in the *Framework Memorandum of Understanding* ("MOU").

#### The M.G.T. Decision

This is a sexual assault case involving a recanting witness. The appellant was convicted of sexually assaulting his wife. Her evidence at trial was corroborated by a third person who overheard the assault and called 911. After conviction, but before sentencing, the appellant brought an application to re-open his case. He filed affidavits from people who claimed to have heard that the 911 caller had fabricated his evidence at trial. The trial judge refused to re-open the case.

On appeal, the appellant argued that the trial judge should have allowed him to re-open. He also sought to introduce fresh evidence of the alleged recantation, and a transcript of the 911 call, which had not been disclosed before trial.

The Peel Crown office policy was not to provide the 911 calls as part of the initial disclosure package. Justice Watt, writing for the Court of Appeal states at paragraph 151:

It is unfathomable that over two decades after *Stinchcombe*, a local Crown Attorney's office would promulgate and adhere to a policy of non-disclosure, at once ill-conceived and constitutionally infirm. Such a policy amounts to an abrogation of the Crown's constitutional obligation, the creation of a *Charter*-free zone that bars entry by an accused to obtain his or her constitutional entitlement. If it persists to this day, it has exceeded its best before date by about 35 years and should cease immediately. [Emphasis added]

#### The MOU

Our MOU, dated June 13, 2017, is a framework agreement endorsed by the Ministry of the Attorney General (MAG) and the Ontario Association of Chiefs of Police (OCAP) for use as a disclosure protocol across Ontario. Disclosure of 911 tapes (and other "recorded incoming communications from public") is specifically addressed in the MOU, at section 5.3:

- 5.3.1 Audio of incoming communications from the public (for example: emergency response calls from civilians or "911 tapes") containing **direct evidence** of the commission of the offence(s) will be provided as part of Initial Disclosure, and where feasible, as part of Bail Briefs.
- 5.3.2 In preparation for preliminary inquiry or trial, and upon the request of the Crown, transcripts of emergency response calls containing **direct evidence** will be produced by Police. The digital format of the audio and/or video recorded emergency response calls must be available for use as an exhibit with a transcript.

"Direct Evidence", as defined in the MOU, refers to "all information establishing and/or corroborating the commission of an offence" (see §1.4.9).

In order for the definition of "direct evidence" to conform to the Court of Appeal's decision in R. v. M.G.T., it must include the following:

- Both inculpatory and exculpatory information;
- Any information that can reasonably be used by the accused in meeting the case for the prosecution, advancing a defence or otherwise determining how to conduct a defence; and
- Unless the information is protected by privilege or clearly irrelevant (e.g. where the communications are clearly not "the fruits of an investigation"), the disclosure practice is to err on the side of inclusion.

Local police chiefs should consult their local Crown Attorneys to ensure that their disclosure with respect to 911 calls is consistent with *R. v. M.G.T.*

SUBJECT: Safe Access to Abortion Services Act, 2017

**COMES INTO FORCE FEBRUARY 1, 2018** 

I am writing to you regarding the Safe Access to Abortion Services Act, 2017 (SAASA), which has been proclaimed and will come into force on February 1, 2018.

As you know, this Act is new legislation that allows for safe access zones to be established around clinics and facilities that offer abortion services, as well as the offices and homes of clinic staff and other regulated health professionals that provide these services.

We ask that the information below about the SAASA be distributed to Chiefs of Police as soon as possible for their information, and that you confirm with us once this has been accomplished.

## The Legislation

The SAASA is new legislation that allows for safe access zones to be established around clinics and facilities that offer abortion services, as well as the offices and homes of clinic staff, and other regulated health professionals that provide these services (see Appendix 1 for the SAASA).

#### 1. Automatic Safe Access Zones

A safe access zone is a zone around a specified location in which certain behaviours are prohibited, such as anti-abortion protesting and activities that intimidate, harass, or interfere with individuals accessing or providing abortion services.

As of February 1, 2018, the eight abortion clinics in Ontario (five in Toronto, one in Mississauga, one in Brampton, and one in Ottawa) will **automatically** receive safe access zones of 50 metres from the boundaries of their property. The names, addresses, and size of the safe access zone for clinics will be listed in a regulation under the SAASA for information purposes (see Appendix 2 for a current list of clinics in Ontario).

Safe access zones of 150 metres will also be **automatically** established around the homes of "protected service providers" (<u>all</u> clinic staff and doctors, nurses, and pharmacists that provide abortion services<sup>1</sup>). These locations will **not** be listed in a regulation.

## 2. Safe Access Zones Established by Regulation

Other facilities, such as health centres, medical offices, hospitals, and pharmacies that offer abortion services will be able to apply to the Ministry of the Attorney General for a safe access zone of up to 150 metres. If a zone around a facility is granted, the location and size of the zone will be listed in a regulation under the SAASA.

The legislation is available online at <a href="www.e-laws.gov.on.ca">www.e-laws.gov.on.ca</a>. The regulation will also be available online after the SAASA is in force.

## Offences under the SAASA

## 1. Prohibited Activities in Safe Access Zones around Abortion Clinics and Facilities

Section 3(1) of the SAASA lists the following prohibited activities within a safe access zone for a clinic or facility. In a safe access zone around a clinic or facility, no person shall:

- advise or persuade, or attempt to advise or persuade, a person to refrain from accessing abortion services;
- inform or attempt to inform a person concerning issues related to abortion services, by any means, including oral, written or graphic means;

- perform or attempt to perform an act of disapproval concerning issues related to abortion services, by any means, including oral, written or graphic means;
- persistently request that,
  - o a person refrain from accessing abortion services, or
  - a protected service provider refrain from providing, or assisting in the provision of, abortion services;
- for the purpose of dissuading a person from accessing abortion services,
  - continuously or repeatedly observe the clinic or facility or persons entering or leaving the clinic or facility,
  - o physically interfere with or attempt to physically interfere with the person,
  - o intimidate or attempt to intimidate the person, or
  - photograph, film, videotape, sketch or in any other way graphically record the person;
- for the purpose of dissuading a protected service provider from providing, or assisting in the provision of, abortion services,
  - continuously or repeatedly observe the clinic or facility or persons entering or leaving the clinic or facility,
  - o physically interfere with or attempt to physically interfere with the provider,
  - o intimidate or attempt to intimidate the provider, or
  - photograph, film, videotape, sketch or in any other way graphically record the provider.

The above prohibited activities do not apply to anything done in the course of a person's work at a clinic or facility, or anything occurring between a person accessing, or attempting to access, abortion services and someone who is accompanying the person with that person's consent.

A person may not be convicted of an offence under section 3(1) of the SAASA unless the person knew or, at any time before the contravention, was given notice of, the location of the relevant safe access zone.

#### 2. Prohibited Activities in Safe Access Zones around Residences

Section 4 of the SAASA lists the following prohibited activities within a safe access zone around a residence. In a residential safe access zone, no person can:

- perform or attempt to perform an act of disapproval, directed at or about the provider, concerning issues related to abortion services, by any means, including oral, written or graphic means;
- persistently request that the provider refrain from providing, or assisting in the provision of, abortion services; or
- for the purpose of dissuading the provider from providing, or assisting in the provision of, abortion services,
  - o continuously or repeatedly observe the residence,
  - physically interfere with or attempt to physically interfere with the provider or a member of the provider's household,

- intimidate or attempt to intimidate the provider or a member of the provider's household, or
- photograph, film, videotape, sketch or in any other way graphically record the provider or a member of the provider's household.

A person may not be convicted of an offence under section 4 of the SAASA unless the person knew or, at any time before the contravention, was given notice of, the location of the relevant safe access zone.

#### 3. Prohibition on Harassment of Protected Services Providers

Section 5 of the SAASA establishes an anti-harassment offence that applies **anywhere in Ontario** to prevent the harassment of protected service providers. Under this section, no person shall, for the purpose of dissuading a protected service provider from providing, or assisting in the provision of, abortion services:

- repeatedly approach, accompany or follow the provider or a person known to the provider;
- continuously or repeatedly observe the provider;
- persistently request that the provider refrain from providing, or assisting in the provision of, abortion services; or
- engage in threatening conduct directed at the provider or a person known to the provider.

Additionally, no person shall repeatedly communicate by telephone, fax or electronic means with a protected service provider or a person known to the provider, for the purpose of dissuading the provider from continuing to provide or assist in the provision of abortion services, after the person being communicated with has requested that such communications stop.

Notice is not required for conviction of harassing a protected service provider under section 5 of the SAASA.

## **Arrest Powers**

Section 12 of the SAASA provides police officers with the power to arrest a person without a warrant if the officer believes, on reasonable and probable grounds, that the person has committed, or is committing, an offence under the SAASA.

## **Penalties**

Individuals who contravene the SAASA will be prosecuted under the *Provincial Offences Act*. For first offences, individuals can receive a fine up to \$5,000 and/or imprisonment of up to six months. For second and subsequent offences, a fine between \$1,000 and \$10,000 and/or imprisonment of up to 12 months can be ordered.

## **Further information**

Please share this memorandum with the appropriate members of your police service.

The Ministry of the Attorney General is currently developing a training deck to support police in enforcing this legislation. As soon as it is available, we will provide the training deck to local Crown Attorneys to be shared with their respective Chief of Police.

## Appendix 1 - Safe Access to Abortion Services Act, 2017

#### **PURPOSE**

## Purpose of Act

1 The purpose of this Act is to protect access to abortion services by protecting the safety, security, health and privacy of persons seeking to access these services and of persons providing, or assisting in the provision of, these services.

#### INTERPRETATION

#### **Definitions**

2 In this Act,

"abortion services" means lawful services provided for the termination of pregnancy including prescribing, dispensing or administering a drug to terminate pregnancy; ("services d'interruption volontaire de grossesse")

"clinic" means a place, other than a place in a hospital, whose primary purpose is to provide abortion services; ("clinique")

"facility" means,

- (a) a place, other than a clinic, where abortion services are provided including, for greater certainty, a hospital, health centre or pharmacy where abortion services are provided, or
- (b) the office of a person who is a protected service provider within the meaning of clause (b) of the definition of "protected service provider"; ("établissement")

"prescribed" means prescribed by the regulations made under this Act; ("prescrit") "property", in relation to a clinic, facility or residence, means,

- (a) property within the meaning of the *Land Titles Act* if that Act applies to the land where the clinic, facility or residence is located and clause (c) does not apply,
- (b) property within the meaning of the *Registry Act* if that Act applies to the land where the clinic, facility or residence is located and clause (c) does not apply,
- (c) property within the meaning of the *Condominium Act, 1998* or as prescribed for the purposes of this clause, if that Act governs the land where the clinic, facility or residence is located as described in clause 2 (3) (a) of that Act, or
- (d) property, as prescribed for the purposes of this clause, if none of clauses (a), (b) or (c) apply; ("unité foncière")

"protected service provider" means,

- (a) a person who works at a clinic, or
- (b) a person who provides, or assists in the provision of, abortion services and who is,
  - (i) a member of the College of Physicians and Surgeons of Ontario,

- (ii) a member of the College of Nurses of Ontario,
- (iii) a member of the Ontario College of Pharmacists who holds a certificate of registration as a pharmacist, or
- (iv) a regulated health professional prescribed for the purpose of this subclause. ("fournisseur de services protégé")

#### **PROHIBITIONS**

Prohibitions in access zones for clinics or facilities

- **3** (1) While in an access zone established under section 6 for a clinic or facility, no person shall,
- (a) advise or persuade, or attempt to advise or persuade, a person to refrain from accessing abortion services;
- (b) inform or attempt to inform a person concerning issues related to abortion services, by any means, including oral, written or graphic means;
- (c) perform or attempt to perform an act of disapproval concerning issues related to abortion services, by any means, including oral, written or graphic means;
- (d) persistently request that,
  - (i) a person refrain from accessing abortion services, or
  - (ii) a protected service provider refrain from providing, or assisting in the provision of, abortion services;
- (e) for the purpose of dissuading a person from accessing abortion services,
  - (i) continuously or repeatedly observe the clinic or facility or persons entering or leaving the clinic or facility,
  - (ii) physically interfere with or attempt to physically interfere with the person,
  - (iii) intimidate or attempt to intimidate the person, or
  - (iv) photograph, film, videotape, sketch or in any other way graphically record the person;
- (f) for the purpose of dissuading a protected service provider from providing, or assisting in the provision of, abortion services,
  - (i) continuously or repeatedly observe the clinic or facility or persons entering or leaving the clinic or facility,
  - (ii) physically interfere with or attempt to physically interfere with the provider,
  - (iii) intimidate or attempt to intimidate the provider, or
  - (iv) photograph, film, videotape, sketch or in any other way graphically record the provider; or
- (g) do anything prescribed for the purpose of this clause.

#### Exception

(2) Clauses (1) (a), (b), (c) and (d) do not apply,

- (a) to anything done in the course of a person's work at the clinic or facility; or
- (b) to anything occurring between a person accessing, or attempting to access, abortion services and someone who is accompanying the person with the person's consent.

Prohibitions in access zones for residences

- **4** While in an access zone established under section 7 for the residence of a protected service provider, no person shall,
- (a) perform or attempt to perform an act of disapproval, directed at or about the provider, concerning issues related to abortion services, by any means, including oral, written or graphic means;
- (b) persistently request that the provider refrain from providing, or assisting in the provision of, abortion services; or
- (c) for the purpose of dissuading the provider from providing, or assisting in the provision of, abortion services,
  - (i) continuously or repeatedly observe the residence,
  - (ii) physically interfere with or attempt to physically interfere with the provider or a member of the provider's household,
  - (iii) intimidate or attempt to intimidate the provider or a member of the provider's household, or
  - (iv) photograph, film, videotape, sketch or in any other way graphically record the provider or a member of the provider's household.

## Harassment of providers

- **5** (1) No person shall, for the purpose of dissuading a protected service provider from providing, or assisting in the provision of, abortion services,
- (a) repeatedly approach, accompany or follow the provider or a person known to the provider;
- (b) continuously or repeatedly observe the provider;
- (c) persistently request that the provider refrain from providing, or assisting in the provision of, abortion services; or
- (d) engage in threatening conduct directed at the provider or a person known to the provider.

#### Same

(2) No person shall repeatedly communicate by telephone, fax or electronic means with a protected service provider or a person known to the provider, for the purpose of dissuading the provider from continuing to provide, or assist in the provision of, abortion services, after the person being communicated with has requested that such communications cease.

#### **ACCESS ZONES**

Access zones for clinics and facilities

6 (1) An access zone is established,

- (a) for each clinic; and
- (b) for each facility prescribed for the purpose of this clause.

#### Extent of zone - clinics

- (2) The access zone for a clinic consists of,
- (a) the property on which the clinic is located and the area within 50 metres, or such other prescribed distance not exceeding 150 metres, from the boundaries of the property; or
- (b) such area with different boundaries, as may be prescribed for the purpose of this clause.

#### Extent of zone - facilities

- (3) The access zone for a facility consists of,
- (a) the property on which the facility is located and the area within the prescribed distance, not exceeding 150 metres, from the boundaries of the property; or
- (b) such area with different boundaries, as may be prescribed for the purpose of this clause.

#### Limitation

(4) No part of an area prescribed for the purpose of clause (2) (b) or (3) (b) may be further than 150 metres from the closest boundary of the property on which the clinic or facility is located.

#### Certain property excluded

(5) The access zone for a clinic or facility does not include real property that one or more persons has the exclusive right to use or occupy if none of those persons is the occupier of the clinic or facility.

## Regulations only on request, after notice

- (6) A regulation prescribing a facility for the purpose of clause (1) (b) or prescribing anything in relation to a clinic or facility for the purpose of subsection (2) or (3) may be made only if the occupier of the clinic or facility,
- (a) has requested the regulation; or
- (b) has been given notice of the intention to make the regulation and a reasonable opportunity to make written submissions before the regulation is made.

#### Revocations not affected

- (7) Subsection (6) does not apply to,
- (a) a regulation that revokes anything prescribed for the purpose of subsection (2) in relation to a clinic that ceases to be a clinic; or
- (b) a regulation that revokes the prescription of a facility for the purpose of clause (1) (b) or that revokes anything prescribed for the purpose of subsection (3) in relation to a facility that ceases to be prescribed for the purpose of clause (1) (b).

#### Access zones for residences

**7** (1) An access zone is established for the residence of each protected service provider.

#### Extent of zone

(2) The access zone for a residence consists of the property on which the residence is located and the area within 150 metres, or such other prescribed lesser distance, from the boundaries of the property.

## Certain property excluded

(3) The access zone for a residence of a protected service provider does not include real property that one or more persons has the exclusive right to use or occupy if none of those persons is the provider or a member of the provider's household.

#### **ENFORCEMENT**

#### Offences

- **8** A person who contravenes subsection 3 (1) or section 4 or 5 is guilty of an offence and, on conviction, is liable,
- (a) in the case of a first offence under this Act, to a fine of not more than \$5,000 or to imprisonment for a term of not more than six months, or to both;
- (b) in the case of a second or subsequent offence under this Act, to a fine of not less than \$1,000 and not more than \$10,000 or to imprisonment for a term of not more than one year, or to both.

Limit on conviction - knowledge or notice of zone

**9** A person may not be convicted of an offence for contravening subsection 3 (1) or section 4 unless the person knew or, at any time before the contravention, was given notice of, the location of the relevant access zone.

### **Damages**

**10** A person who suffers loss as a result of a contravention of subsection 3 (1) or section 4 or 5 by another person has a right of action for damages against that person.

#### Injunction

**11** On application by a person, including the Attorney General, the Superior Court of Justice may grant an injunction to restrain a person from contravening subsection 3 (1) or section 4 or 5.

#### Arrest without warrant

**12** A police officer may arrest without warrant a person the officer believes, on reasonable and probable grounds, has committed, or is committing, an offence under this Act.

#### **REGULATIONS**

#### Regulations

- 13 The Attorney General may make regulations,
- (a) prescribing anything that is referred to, in this Act, as prescribed;

- (b) setting out, for information purposes, the names and locations of the clinics in Ontario and descriptions of the access zones established under section 6 for those clinics.
