Chris Vankoughnett owner of Apex Helicopters, delivered a presentation in support of the Richard W. LeVan airport, noting that the airport has potential for economic development in North Huron and the surrounding area.

Discussion took place regarding options for the future of the airport. CAO Sharon Chambers reported that Huron County is reviewing airports this summer as part of their economic development strategy. It was also noted that the original intent for the farm land in which the airport is located, was to offset operating costs of the airport.

Reeve Vincent left the Chair and it was assumed by Deputy Reeve Campbell so that Reeve Vincent could comment on the airport discussions. Reeve Vincent reassumed the Chair after making his comments.
