Chief's Letter

4 April 2017

I am pleased to present to the board the 2016 yearend report for the Wingham Police Service.

2016 showed an overall increase of 4.9% in the number of calls for the Wingham Police Service with 1583 reported incidents. Of these incidents only 15.4% were criminal in nature however 227 Criminal, drug and Youth Justice charges were laid as a result of these incidents. 84.67% of calls to the police service in 2016 were non criminal in nature.

We continue our alliance with Saugeen Shores Police Service to conduct our required refresher training. In order to maintain the Ministry Standard, this training is conducted every six months instead of the required once every 365 days. We are utilizing Hanover Police Service for Conducted Energy Weapon Training.

Wingham Police currently has a police officer on duty in Wingham 24 hours a day, seven days a week and we have officers trained in almost all aspects of policing. In keeping with our community survey and business plan, we have one additional officer trained in drug investigative techniques. This has resulted in 93% of our drug related calls being cleared by charge.

Our officers know the community and immediately recognize when something seems out of place.

Our school patrols at the high school are remaining constant. We have received several favourable comments from the staff and students about our involvement there. This year we continued with the officers assigned specifically to assist each school. This project appears to have gone well.

In 2017 we needed to update our aging fleet of vehicles. With the purchase of a 2017 Ford Police Interceptor (Explorer) we were able to donate our 2004 Ford Taurus to the Fire Department of North Huron for training purposes. We currently have two fully equipped police cruisers and one partially equipped vehicle that is used only as an administrative vehicle.

I look forward to working with our community on the challenges the upcoming years will bring.

Wingham Police Service

Training

All officers attended the required annual use of force training with Saugeen Shores. This training covers firearms, use of force, pursuit driving and cultural awareness.

2016 Programs

Officers in Schools

When officers were available, we continued to be involved in the schools. Officers have participated in classroom lectures at the high school and attended as guests in classrooms in the Public School and Sacred Heart Catholic School. Often, officers would conduct foot patrols of the high school giving an opportunity for students to approach them. We expect this to continue for 2016.

R.I.D.E.

The R.I.D.E. Grant amount was allocated to Wingham Police Service for a two year period. Our funding request for \$4451.08 has been submitted to the province for payment. With this funding we were able to dedicate approximately 68 additional hours on R.I.D.E. over and above the hours committed during regular shifts. For a fifth year in a row, we did not report any drinking and driving offences during these checks. There was however several Highway Traffic Act and Liquor License Act offences detected.

C.H.I.P.

The Chief maintains membership on the Coalition for Huron Injury Prevention Committee. This committee has representatives from most county municipalities, MTO, Wingham Police and OPP. This committee continues to support the municipalities with the speeding campaigns as well as seniors driving education and radio advertising to educate the public about safety. Due to other commitments, we have not been able to attend all of the meetings however we are still active members in the organization.

Domestic Violence

We continued to participate in the Domestic Abuse Review Team for Huron County. Sergeant Foxton regularly attends meetings where the group reviews selected domestic violence cases and puts recommendations forward for resolutions. During 2016, Wingham Police responded to 18 domestic disputes. Only one of these reports resulted in charges being laid.

Clearance Rates

The Uniformed Crime Report Statistics Has changed their way of reporting. In the past, all of our incidents clearances were included for example if we cleared something as "Complete Solved" it would show up as a positive clearance. This year, all complete solved are bulked together and approximately 67% of our incidents. For the remaining 530 incidents, 163 were cleared by charge and 179 were cleared otherwise for a total of 23%. The total of incidents successfully cleared was 90% which is a slight increase over last year.

Overall the service was \$4521.01 under budget. In addition to the above, \$39,000 was budgeted for a new police cruiser. The purchase of the cruiser and transfer of all components from old to new totaled \$39,214.73.

Provincial Reporting Requirements

a) all police facilities:

- meet or exceed provincial building and fire codes;
- we have sufficient space for the efficient organization of offices and equipment;
- be adequately heated, ventilated, illuminated and, where appropriate and practical, air conditioned, when in use;
- a separate change area is not required as members are not required to change at the workplace.
 We do have separate washroom facilities. We have only one shower facility; and
- have appropriate security measures and communications. The security measures were
 upgraded in 2012 with the renovation of the front entrance. The vestibule is now open 24 hours
 a day and an electronic combination lock was installed for easy access to the officers. This area
 is under 24/7 camera surveillance. The alarm system for the building was also upgraded and is
 now monitored rather than just the audible alarm;

b) members of the police service have available:

- · appropriate and secure working, records and equipment storage space; and
- · separate or private areas for interviewing purposes; and

c) the police service's lock-up facilities meet the following requirements:

- the minimum cell size is 7' x 4'6" x 7' high;
- fire extinguishers are secure and readily available in the lock-up area, but out of reach of the person in custody;
- smoke and heat detectors are installed in the lock-up area;
- toilet facilities are provided in each lock-up;

- first aid equipment, including airway devices for mouth to mouth resuscitation, are readily available;
- lock-ups are separate from public view;
- confidential interviews with legal counsel can be accommodated. This could be done better
 with a minor renovation in adding a sound proof phone booth. This is to be put on the "wish
 list" with the facilities manager. To date, there is no funding to conduct such renovations;
- a proper area for prisoner processing is provided;
- cell keys are in a secure location and master or duplicate keys are readily available;
- the area where prisoners are processed and/or searched is well illuminated, secure and has no hazardous conditions present;
- compliant with the police service's policy and procedures with respect to communicable diseases; and
- a means of constantly communicating with the main desk area and/or the communications centre is available.

Complaints Against Police

During 2016, Wingham Police Service received one complaint from the OIPRD. That complaint is being investigated by one of their investigators.

Special Investigations Unit Investigations

The Wingham Police Service were not involved in any incidents where the SIU had to invoke their mandate.
