- 11. Wi-Fi Downtown wide wi-fi project is being explored through a community sponsorship project that CIBC provides to community as part of their exit strategy. The BIA will have them go ahead and determine the set-up costs and ongoing expenses before agreeing to allow them to set it up. The project would have to be through Bell Canada, as that is the provider their Community Wi-Fi projects all use.

## 13. Community Improvement Plan – Blyth & Wingham

Laura Simpson of the Huron County Planning Dept presented a draft copy of the plan, explaining that once approved it would facilitate the community revitalization program that they have received a \$42000 grant through OMAFRA for. This will be in consultation with the BIA's, EcDev Committee, and a town hall/open house style meeting with the public. Ideally they would like to have a draft to council in September. The Blyth BIA suggested expanding their geographic location to be Queen St from Westmoreland to Blyth Road (instead of Drummond to King), with the stipulation that it focus on commercial properties, i.e. façade improvements, accessibility and pedestrian safety.

**14. Bike Repair Shop** – The BIA met Jason Lamont and welcomed his bicycle repair shop, operating currently behind Pick a Posie at the corner of Queen and Dinsley Sts.
