Engineer's Report

Whitfield Municipal Drain Relocation Project 2022

Being a by-law to provide for a municipal drain improvement in the Township of North Huron, in the County of Huron; Whitfield Municipal Drain Relocation Project 2022

WHEREAS the Township of North Huron, in the County of Huron in accordance with the provisions of Section 78 of the Drainage Act, R.S.O. 1990, has procured a report for relocation of the Whitfield Municipal Drain:

Lands and Roads in Blyth Ward of the Township of North Huron impacted by this drain, as follows:

- MORRIS CON 9 PT LOT 1;
- CON 9 N PT LOT 1 N PT LOT 2; and
- PLAN 173 BLK L PT BLK D TO; PT BLK F

AND WHEREAS the Council of the Township of North Huron, in the County of Huron has procured a report made by GM Blue Plan, 975 Wallace Avenue North, Listowel, ON N4W 1M6; and the report is attached hereto and forms part of this by-law;

AND WHEREAS the estimated total cost of relocating the drainage works is \$16,460.00;

AND WHEREAS the Council is of the opinion that the relocation of the drainage is desirable;

NOW THEREFORE the Council of the Corporation of the Township of North Huron under the *Drainage Act*, ENACTS as follows:

- 1. The report dated November, 2021 and attached hereto is hereby adopted and the relocation of drainage works as therein indicated and set forth is hereby authorized and shall be completed in accordance therewith;
- 2. The Corporation of the Township of North Huron may borrow on the credit of the Corporation the amount of \$16,460.00 being the amount necessary for the improvement of the Drainage Works, less the following:
 - a) Grants received under Section 85 of the Act;
 - b) Commuted payments made in respect of lands and roads assessed within the municipality; and
 - c) Money paid under subsection 61(3) of the Act.
- 3. A special rate, sufficient to pay the amount assessed plus interest thereon, less any applicable grants, shall be levied upon the assessed properties in the Blyth Ward, Township of North Huron, after the passing of this By-law and the completion of the relocation of the Whitfield Municipal Drain Relocation Project 2022, and shall be collected in the same manner as other taxes are collected.
- 4. That all assessments are payable within 30 days of an invoice being issued to the affected landowners, unless other arrangements are approved by Council.
- 5. This by-law comes into force on the final passing thereof, and may be cited as the "Whitfield Municipal Drain Relocation Project 2022 By-law."
