Training

We will be conducting refresher Taser training with Hanover Police Service in January and early February.

Grants

In late December we were contacted by the Ministry advising that the CPP and 1000 Officers grants will be terminated in March of 2017. The notification indicated that we could apply for up to the \$90,500 for "Modernization." Several examples were given such as partnering with the local mental health and having a team response to these calls. Initially they were requesting a response by 10 February but this has since been extended.
